### **SUMMARY ANNUAL REPORT**

#### FOR SEIU LOCAL 105 HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report for the SEIU Local 105 Health and Welfare Trust Fund, E.I.N. 27-1372825, Plan No. 501, for the year ended December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has a contract with Kaiser Foundation Health Plan of Colorado to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2018 was \$3,962,963.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$2,662,193 as of December 31, 2018, compared to \$2,379,819 as of January 1, 2018. During the plan year the plan experienced an increase in its net assets of \$282,374. This increase includes realized and unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$4,532,698 including employer contributions of \$4,429,426, participant contributions of \$84,670, losses of \$3,336 from the sale of assets and earnings from investments of \$21,938.

Plan expenses were \$4,250,324. These expenses included \$195,316 in administrative expenses and \$4,055,008 in benefits paid to or for participants and beneficiaries.
